






Project Portfolio Management

This creates a sound basis for selecting the right projects using visual (project matrix) and valuebased presentations.


The aim of project portfolio management is to optimize the use of limited resources for upcoming projects in a structured decisionmaking process.

Risk management in **STRATandGO™** comprises all activities for identifying, assessing, managing and monitoring all material risks, including reporting to stakeholders.


It creates transparency and links risks with early warning indicators, measures, projects, contracts, ICS (Internal Control System) processes and other individually configurable influencing factors.


STRATandGO[™] supports all parties involved, such as managers, employees and supervisory bodies, in fulfilling these obligations.

Information Security Management System


In a world dominated by digitalization and networking, security is not a luxury, but a fundamental necessity. A single security incident can cause devastating economic damage.
